However, you must follow our instructions and use the provided safety equipment at all times. Adults accompanying any person under the age of 18 must ensure the underage person follows our instructions at all times. You must release or indemnify Canoe & Kayak North Shore, and our staff against any liability we incur to anyone else, resulting from your failure to follow our instructions or the failure of any person accompanying you under the age of 18 to follow our instructions.

We reserve the right to withdraw any person who in our opinion is likely to endanger themselves or others. We also reserve the right to cancel the tour if we become concerned for any reason for your safety or that of any other person.

WARNING: Under New Zealand law it is extremely unlikely that you will be able to sue anyone if you are injured.
