- *I have inspected the equipment hired to me and agree that it is in good condition, complete and suitable for its intended use.
- *That a charge of \$1 per km will apply for drop offs and pickups.
- *That no credits will be given for bookings cancelled within 24 hours of the booking and that refunds will not be given.
- *That bookings cancelled within 24- 48 hours before the day will receive a 50% credit and that refunds will not be given.
- *That bookings cancelled more than 48 hours before will receive a full credit and that refunds will not be given.
- *That equipment returned late will incur a full day extra hireage cost.
- * That all equipment must be returned clean and rinsed in fresh water. A surcharge will apply if cleaning is required.
- * That the information I have provided is honest and accurate.
